Total expenditure for 2017 is estimated at US\$13.1million, approximately 32 percent greater than our 2016 spending. This increase reflects new planned activities in Country Work, Strategic Initiatives, and Training and Technical Assistance. With the Country Work program, we will continue intensive work in India, Kenya, and South Africa, while expanding the work under the SPARK (Seeding Public Accountability for Results & Knowledge) program to include two new countries. The majority of this spending comprises sub-grants and capacity-building support for our civil society partners, as well as learning-focused case studies on the impact of our partners work in each of the countries. The increase in Strategic Initiatives includes significant investments in strategic planning, IBP's 20th anniversary event, new senior staff positions, and work around revenue and tax policy. With Training and Technical Assistance, IBP will continue supporting partners in strategic communications, enhanced work on tax policies, and a leadership development initiative. The leadership development initiative is a new project aimed at identifying and nurturing future leaders from within IBP and our partners. Additional activities include a project on monitoring budget implementation methodologies and grants for horizontal learning and exchanges between partners. The increased expenditures in Fundraising are due primarily to the anticipated hiring of IBP's first dedicated senior fundraising staff member, who will help develop and implement IBP's ongoing fundraising strategy.
