In 2017 IBP also laid the groundwork for extending its in-depth country work to four new countries.

(Revenue \$) Strategic Initiatives - In 2017 IBP supported special projects related to developing a new organizational strategic plan that charts a vision for the organization's work from 2018 - 2022, as well as conducting research that lays the groundwork for global programming to encourage equitable tax policies and practices. IBP also supported 10 in-country partners in Latin America working to research and encourage - at both the country and regional level - the transparency, accountability and equity of policies and practice on tax expenditures (such as tax deductions and credits that benefit specific activities or groups of taxpayers).

(Revenue \$) Research: IBP's Open Budget Initiative is a global research and advocacy program that promotes public access to government budget information and the adoption of accountable budget systems.
